- O Include evidence of name variations on documents, e.g. Marriage Certificate, Statutory Declaration
- O Include degrees or diplomas awarded for your qualifications (in home language and certified English translation)

- O Include all secondary school certificates and mark sheets
- O Include academic transcripts/mark sheets for your qualifications (in home language and certified English translation), including details of the grading system and/or subject legend
