**Important Information T&Cs:** We ask that you register and pay the deposits to attend the Tax Cruise and Tax Training at the same time to secure your spot. While it is not mandatory that you opt into our travel package, it is preferred so we can secure our group rate.

**Cancellation Policy:** Of the \$350 travel deposit, only \$100 is refundable (\$250 is allocated to the Qantas Airfares & \$100 is allocated to the Cruise component). The \$100 deposit for the tax training is fully refundable until 30 August 2019. The balance due depending member and non-member status, departure city, cabin type and travel dates will be due in staggered payments prior December 2019. **Travel:** The per person package prices are based on group booking rates secured through Orbit World Travel. Quoted prices may vary depending on when you book, travel dates, departure city, cabin type and status of group book allocations. Delegates are encouraged to obtain quotes through Orbit World Travel to be fully informed on total travel costs. Pricing is quote only and subject to confirmation of cabins requested/cabins allocated for quoting purposes, space reviews, departure city and availability of fares (currently quoted off this year as 2020 have not been released as yet), number of rooms at hotel, average age of 55 with no pre-existing medical conditions, foreign currency exchange rates, minimum group sizing and change to current dates. Taxes, port fees, gratuities all included in price, as is daily breakfast at pre-cruise hotel. Government taxes, as well as airline surcharges are however, subject to change at any time until documents have been issued. Flights are based on direct QANTAS options, except Adelaide departure which is via Melbourne or Sydney. **Single supplement pricing available**, or option to match you with a fellow traveller (bedding subject to confirmation). **Option to downgrade hotel pre-cruise**, saves approximately \$25 per person and would be the Orchard Rendezvous Hotel 20 minutes' walk away. Subject to group rate availability. After total group confirmation, further booking discount may be applicable to quote, subject on the above. **Passengers are responsible for obtaining current passports with more than 6 months validity at time of travel and at least 2 blank facing pages.**

**Deposit conditions:** Of the \$350 deposit, only \$100 is refundable, up until 160 days prior to departure or before final payment, whichever comes first.

**Payment schedule:** \$350 registration deposit, followed by staggered payment until December, schedule to be advised once group numbers are finalised.

**Conditions of Registration:** The IPA reserves the right to alter a program or presenter without notice, however, the program is intended to run as advertised. The IPA cancels seminars only when absolutely necessary, but reserves the right to do so, as well as to reschedule seminars and substitute presenters.
