#### BOOKING DEADLINE, WAIT LIST AND CONFIRMATION

A confirmation email will be sent to you within 1 – 2 business days of the IPA receiving your registration form. Please notify the IPA by phone or email if you do not receive a confirmation email within this time frame. Registrations are based on a first-in-first served basis. A wait list will be taken once maximum numbers have been reached.

#### CONDITIONS OF REGISTRATION

Payment is required within 14 days of invoicing. Full payment deadline is Friday, 19 February 2021. The IPA reserves the right to withdraw or cancel a delegate's registration should payment not be received by this time. IPA reserves the right to alter a program or specific presenter without notice, however, the program is intended to run as advertised. Delegates are required to attend all events as included in the agenda. Should the delegate be unable to attend due to illness or injury they must notify the IPA group host immediately.
