Trusts, Partnerships and The Small Business Rollover

We will discuss the key features including perpetuity period, holding period rule and reporting rules, taxation treatment of different income sources, key trigger points and consequences of resettlements and more. This session will discuss family trusts as well and the rules around losses in a family trust.

An in depth discussion of the taxation treatment of partnerships, drawing on recent case law, it will cover how to correctly determine its income and also how to correctly calculate its taxation liabilities (including GST and CGT). We will discuss the usefulness of the structure as well as its limitations.

In the Small Business Rollover session we will discuss how to make this legislative change work for your clients, trust cloning, ultimate economic ownership test and transferring assets.

Capital Gains Tax is one of the most litigated areas of taxation because its provisions are so pervasive that complicated CGT problems can be born out of seemingly innocuous transactions. Therefore, it is imperative to know exactly when CGT is payable and to get your calculation right.

In this session we will focus on CGT events, provisions that apply in a variety of commercial and non commercial contexts, rollovers and concessions (including 15 year exemption, 50% active asset reduction; retirement exemption and rollover) and a deep dive into the order in which these concessions should be applied. We will draw from the recent case law to give delegates a deeper understanding of how to handle CGT issues that might arise in their work.
